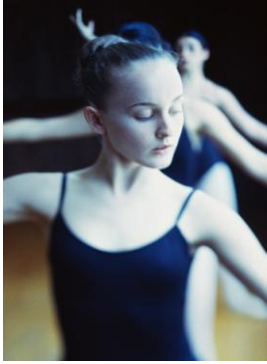
TAP PROGRAM
